- Instructional materials
- Programs & Supplies

Operating Expenses

- Insurance
- Utilities - electricity, heat, water, garbage disposal, etc.

General Fund Levy Requests:

- Total levy amount: \$105,134
 - Cost: \$0.79/year per \$100,000 in assessed property tax value

- High School District**
- Total levy amount: \$403,627
 - Cost: \$1.65/year per \$100,000 in assessed property tax value

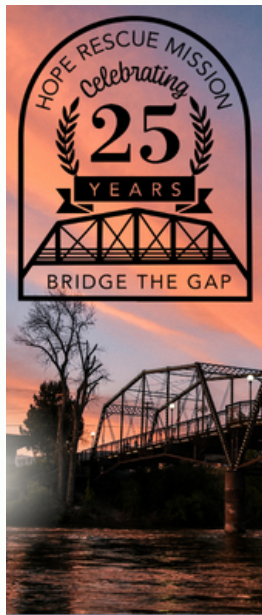

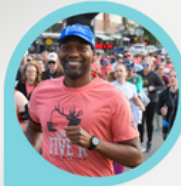
